

Off Season Player signings/OHA/USA Hockey/Development fee/Player Release

There have been many calls about the fees associated with any Off-Season Player signings/OHA/USA Hockey/Development fee/Player Release transactions.

Any player who is traded between CJHL teams in other Leagues – there must be a completed CJHL trade form completed with all three pages. There is a CJHL trade fee of \$150.00. This is payable to the NOJHL who will then pay the CJHL. There is a NOJHL trade fee of \$200.00 plus \$26.00 HST on each trade. If this transaction involves an Inter-Branch transfer there is a fee of \$50.00 plus \$6.50 HST for players from HEO or HNO. Players from other Provinces the fee is \$100.00 plus \$13.00 HST. The NOJHL will invoice you.

Any player traded within the NOJHL- there must be a completed CJHL trade form completed. There is a CJHL trade fee of \$75.00 for each team. This is payable to the NOJHL who will then pay the CJHL. There is a NOJHL trade fee of \$100.00 plus \$13.00 HST on each trade for each team. The NOJHL will invoice you.

Any player traded between the NOJHL and Junior B or C teams within Canada – all trade information is to be written out on team letterhead and submitted to the NOJHL (Ted Magee). There are no CJHL trade fees. There is a NOJHL trade fee of \$200.00 plus \$26.00 HST on each trade. The NOJHL will invoice you.

Players that you obtained through OHF Regulation E107 from Junior B or Junior C. You must complete the appropriate paperwork that you received. There are no trade or transaction fees as you must pay the player development fees as per the Regulation E107 scale. The NOJHL will forward payment to the OHA Office. The NOJHL will invoice you.

Players that you obtain from Minor Hockey through OHF Regulation E107 from other Member Partners of the OHF – You must complete the appropriate paperwork such as the “NOHA Minor to Junior Permission to Skate Form” and the “NOHA Minor to Junior Player Release Form”. There are not trade or transaction fees as you must pay the Player Development fees as per the Regulation E107 scale. Copies of the forms must be submitted to Ted Magee. You must inform Ted Magee as to which OHF Member Partner the team belongs to so the payment can be sent to them. The NOJHL will invoice you.

Players that you obtain from Minor Hockey through OHF Regulation E107 from NOHA Associations or Teams – You must complete the appropriate paperwork such as the “NOHA Minor to Junior Permission to Skate Form” and the “NOHA Minor to Junior Player Release Form”. There are no trade or transaction fees to pay. Copies of the forms must be submitted to Ted Magee. The NOJHL will submit the payment to the NOHA Office for distribution as per OHF Regulation E107. The NOJHL will invoice you.

Any players that are obtained through the automatic payment of Player Development Fees – there are no transaction fees applied.
